status or enrollment status with the State Bar Council, as applicable.

- Comply with the conditions outlined for my category and fully adhere to the
process established by the Bar Council of India for maintaining the integrity

I further confirm that I understand the eligibility criteria and agree to comply with all instructions and regulations as indicated by the Bar Council of India. I acknowledge that intimation of my case will be provided to the Bar Council of India for the purpose of maintaining transparency and proper records.

I understand that providing any false information or non-compliance with the criteria mentioned may result in disqualification from the AIBE or withdrawal of eligibility for enrollment.

All such candidates who are in the final year, and final semester of their 3 year or 5 year integrated LL.B degree course, must attach their self-attested & scanned (not clicked from mobile) marksheet for each semester i.e., in case of 3 Year LL.B. degree course marksheet of Semester-I to Semester-V and in case of 5 Year LL.B integrated degree course marksheet of Semester-I to Semester-IX in the prescribed form/undertaking.

All such candidates who have passed the LL.B degree course but have not yet obtained their Law degree must attach their self-attested & scanned (not clicked from mobile) all their marksheets i.e. in case of 3 Year LL.B. degree course marksheet of Semester-I to Semester-VI and in case of 5 Year LL.B integrated degree course marksheet of Semester-I to Semester-X in the prescribed form/undertaking.
