NOTE:

1. There is no choice selection in round 2, hence the candidates who get allotment in the second round have to compulsorily report to the allotted college as the seat allotment is based on the priority of options as entered by the candidates.
2. The Choice 2 candidates of first round, if the seat is upgraded will report to the new college or if the seat is not upgraded, will report to the previously allotted college.
3. Not reporting to the allotted college should not be presumed by the candidates that they have surrendered the seat to KEA. This is tantamount of blocking of seat and it attracts penalty, further Government shall initiate legal action in accordance with law against those candidates who fail to take admission in the college allotted in round 1 or round 2.
