## ALL INDIA LAW ENTRANCE TEST-2021

### NOTIFICATION-B.A.LL.B.(HONS.) PROGRAMME

- The Registration Process of [Online Counselling](#) for admission to National Law University Delhi was started for B.A.LL.B.(Hons.) Programme on Thursday, August 5, 2021.
- The candidates registered for the Online Counselling and have paid the Counselling Fee of ₹50000 till 2.00 P.M. of August 7, 2021 have been considered for [First Provisional Merit List of Selected Candidate \(category wise\) and Waiting List for admission to B.A.LL.B.\(Hons.\) Programme.](#)
- Based on the available vacancies **Second Provisional Merit List of Selected Candidate (category wise) for admission to B.A.LL.B.(Hons.) Programme is annexed as Annexure-A.**
- The candidates who appear in the **Second Provisional Merit List of Selected Candidate (category wise) for admission to B.A.LL.B.(Hons.) Programme should pay their balance fee of ₹82500 on or before 5.00 p.m. on Monday, August 16, 2021, through any of the Digital Payment methods viz .Credit/ Debit Card, Net-banking, UPI, etc. failing which the offer of admission will be cancelled and the seat will be offered to the next candidate in order of merit of the concerned category from the Waiting List.**
- The portal/interface for payment of balance fee & downloading of Provisional Admission Offer Letter by the provisionally selected candidates will be activated from 4.00 P.M. on Friday, August 13, 2021.

- In case, the candidates do not accept the offer of admission for any reason whatsoever, it will not be considered afterwards under any circumstances and they will forfeit the right of admission along with the right to refund the Counselling Fee of ₹50000/-. No request shall be entertained in this regard.
- **STEPS TO PAY THE BALANCE FEE & DOWNLOADING OF PROVISIONAL ADMISSION OFFER LETTER:**
- **Step 1:** Go to the Portal/interface <http://nludelhi.admissionhelp.com/>
- Login using the following combinations:
  - a) **Roll No. OR Application No.**
  - AND**
  - b) **Applicant's Date of Birth**
- **Step 2 : Download Provisional Admission Offer Letter**
- **Step 3 :** Upload signed **DECLARATION BY THE CANDIDATE & PARENTS.**  
The performa for uploading the declaration by the candidate is provided with the Provisional Admission Offer letter.
- **Step 4:** Payment of Balance Fee:
  - a) Candidates shall login to their Application Account, click on Pay Balance Fee
  - b) Click on '**Pay Now**'. The candidate will be taken to the Online Payment Gateway and will complete the transaction for balance fee of ₹82500. After the payment is successful, an Acknowledgment Slip will be auto generated. **The candidates are advised to keep a print out of Acknowledgment Slip for future reference.**
